**L.I.F.E. Nehemiah Action:** Friends raised a concern that the Nehemiah Action planned for March 9 comes at a time when people are being encouraged to not attend large crowd function because of health risks associated with COVID-19. The Meeting is in full support of the goals of the Action. But many may choose to not attend because of this health issue. We recognize that each individual in the Meeting can make his/her own decision about attending or not. Friends expressed the need to show support to Carolyn Stanley, our representative to LIFE.

- ❖ **2020-MM06:** We ask the Clerk to draft a letter to our elected officials explaining our potential low attendance at LIFE's Nehemiah Action, but expressing the absolute importance of addressing the goals of LIFE regarding affordable housing and day care and the proper use of civil citations for youth. This letter will be given to Carolyn Stanley to be read at the Nehemiah Action, if appropriate, and will be sent to the local press. We will publish the letter in our newsletter and encourage individuals of our Meeting family to communicate to the elected officials. [*Note a letter was not read but will be written and sent to the newspapers*]

**Our Relationship with our Native American Predecessors.** Chris Ruhnke and Susan Oehl were asked to design a public document for hanging in Iona House. Expenses will be paid by the Meeting.

The **Environmental Working Group** is currently focusing most of its attention on supporting Chris Ruhnke's leading to establish a greenway along the Yellow Fever via the 20-20 effort.

We are weighing the potential conflict of using reusable dishes and cups for ecological reasons and disposable items to address the current health scare. We will have disposable items available for the April Potluck. [*if held*]
