#### Queries:

- How do we foster a spirit of community among the meeting's members and attenders?
- How does the meeting keep in contact with all of the meeting's members and attenders?
- How does the meeting assist couples and families to communicate, grow together, and rear children in a loving environment?
- Does the meeting community nurture the meeting's children?
- How does the meeting care for those who live alone, the sick, the aging, the widowed, the separated or divorced, and others with families affected by disruption?
- Do we assist Friends in need as their circumstances require?
- How do we labor with and care for those whose conduct or manner of living gives grounds for concern?
- How are visitors to our meeting made to feel welcome?

 Do we respect that of God in each person, though it may be expressed in unfamiliar ways or may be difficult for us to discern?

#### Advices:

- Be truthful and sincere, and thus encourage these qualities in others.
- Through example and education, help each other to recognize and follow the voice of God both in our spiritual lives and in joyful and willing service.
- Watch with tenderness over the opening minds of children. Seek to awaken in them the love and understanding of the life and teachings of Jesus and a sense of security in the love of God.
- Remember that there is a unique potential in each human being as a beloved child of God and that the Holy Spirit may lead children to give wise counsel to listening adults.
- Young people, too, have responsibility to care for the meeting and to participate in meetings both for worship and for business. Faith is needed as a vital part of our living.

# Fort Myers Monthly Meeting of the Religious Society of Friends Minutes of 4th Month 19, 2020

The Fort Myers Monthly Meeting of the Religious Society of Friends met online on the 4<sup>th</sup> month 19<sup>th</sup> day via Zoom conference with ten Friends present. The Meeting opened with a period of silent centering. Out of the silence, Friends shared how they are coping with the COVID-19 pandemic. It was clear from the sharing that there were some hardships, but also many opportunities. Friends also shared their concerns about the impact of the pandemic on the greater community, especially in Florida.

#### **Treasurer's Report**

Treasurer Paul Davis presented the Financial Report. He noted that we are fairly well off financially at this time. The Friends Fiduciary Fund has dropped by 13.2%, due to the current economic climate. He has paid off our full annual budget commitment to both LIFE and the Food Bank to assist them in this period.

#### Plight of Immokalee residents/farmworkers during pandemic

Peace and Social Concerns Committee is concerned about the plight of residents and farmworkers in Immokalee, specifically the lack of a field hospital and aggressive testing for COVID-19. P&SC has prepared a draft letter to both Governor Ron DeSantis and Agriculture Commissioner Nikki Fried that they ask the Meeting to approve and send out immediately. P&SC Clerk Carolyn Stanley noted that the Coalition of Immokalee Workers urges such action even though the governor has stated he does not think the field hospital necessary. The letter below is ready to go by mail and email to both.

## ❖ 2020-MM07: Friends approve the following letter expressing the need for the state to proactively address the health needs of Immokalee workers.

Dear Governor DeSantis and Commissioner Fried:

The Executive Order 20-91 determines farmworkers to be essential. We are very concerned about their health. The Fort Myers Monthly Meeting of the Religious Society of Friends urges you to set up a field hospital in Immokalee during the Pandemic. This

will secure aggressive community testing for the Corona Virus and will treat and isolate both severe cases and workers who test positive despite being only mildly ill or symptom-free. This will prevent the spread of the virus in overcrowded homes.

These people are essential workers who are harvesting crops and riding packed buses to work. Health care when available is miles away! Currently the health centers in Immokalee are not seeing drop in patients. Lack of medical resources will exacerbate the pandemic if no emergency measures are in place. Naples hospitals are not the solution.

In spite of Collier County Dept of Health statements that the Healthcare Network of SW Florida is sufficient, we strongly encourage you to take a more proactive response to establish a field hospital immediately. We are aware the Army Corps of Engineers has plans ready to go that can be adapted to use local contractors.

Thoughts about the question of how to increase Friends' sense of involvement in the Meeting during this social distancing period:

- o Perhaps we need clearer guidelines about group discussions/worship sharing
- o Perhaps opening any discussion/worship sharing group should begin with sharing of observations on dealing with the current restraints.
- We also may need one-to-one outreach as a prelude to any group meeting and as a way for some to become more comfortable with the process.
- Some felt it important that Friends reach out to others in the Meeting, and then encouraging those other Friends to also reach out.

Ministry & Counsel Committee reported that the **DeOliveira/Goldey wedding**, originally scheduled for April 25, has been postponed until further notice. The couple are not anticipating moving out of the area at this time. We hold them in our thoughts.

We closed in silent worship.

# Southeastern Yearly Meeting News

The SEYM Virtual Mini-Gathering proved to be a wonderful way to respond to our need for spiritual renewal and community in this time of physical distancing. 112 Friends attended the sessions; Quakers from SEYM Meetings and Worship Groups, along with Friends from New England and Philadelphia Yearly Meetings and other Quaker organizations. Many were present for almost all the sessions, while others dropped in for workshops that fit their schedule or interests. Held over the five days slated for the Yearly Meeting Gathering, April 8-12, the 'VMG' offered Worship Sharing, Youth Program activities, workshops, a Young Adult 'Internet Film Festival,' and a Talent Show Saturday night. Sessions concluded with Meeting for Worship on Sunday afternoon. It was a lighter schedule than the in-person Gathering, allowing Friends to take ample time away from their computer screens.
