The Fort Myers Monthly Meeting of the Religious Society of Friends met for Business in hybrid format on 11th month, 12th day with 14 Friends present. The Meeting opened with a period of silent centering. Clerk Richard Frechette read from SEYM's Queries & Advices for 11th Month on Care Of The Natural World:

- Do we live in harmony with nature? Do we live in keeping with the spirit of unity, sacredness, and integrity of all creation?
- Do we seek to minimize our consumption of the earth's resources? Do we encourage equitable and sustainable use of those resources?
- Do we walk gently over the earth, seeing that of God in all of nature? Several responses:
 - My first thought is to take this advice personally and try to pass through this world with a smaller footprint. Voting for leaders that have wisdom in that area would probably do even more good. Not that you can't do both.
 - "Gently" to me could be interpreted as awareness and sensitivity, recognizing the natural world around us and honoring it.
 - This morning someone sent a photo of a snake to a neighborhood email group, asking if she should kill it. Several people responded, "Why kill it, why not just live with it? Eventually it will move on." In fact, a lot of

people said that, and I chimed in with that. I would give it the peace sign and go my own way. You should make room for other creatures in your path, rather than destroy them just because you're afraid of them. I know friends who are terrified of spiders. Why? I leave spiders alone because they've done me a lot of good over the years.

• As a corporate group we're trying to honor the natural world with the design of the new Meetinghouse, keeping our footprint small, surrounding it with nature.

Meetinghouse Committee Report

Meetinghouse Committee Clerk Helen Fox reported on the progress of the construction of the new building:

We expected to break ground this month. Unfortunately, there have been slowdowns at the level of the County, which is backlogged with requests for permits after Hurricane Ian. But in addition, the architect and the prospective contractor, both strong, colorful personalities, have sharp differences of opinion about the design of the interior. We are continuing to try to mediate.

SEYM Meeting for Business Report

Richard & Suzanne Frechette had attended SEYM Fall Interim Business Meeting in Sarasota last month, representing Ft. Myers Meeting. Friend Suzanne reported.

There was much discussion of the "Apportionment" methodology relating to support for the Yearly Meeting by Monthly Meetings and Worship Groups.

The current standard is to determine the budget requirement for Yearly Meeting for the year, then divide by the total number of members and attenders (with attenders being identified as .5 unit) to determine the unit cost. The apportionment for each MM/WG is then determined by multiplying the unit cost by 1 for each reported member and .5 for each reported attender.

It was noted that the formula is a suggestion, but that MMs determine what they feel is a fair amount to contribute. Currently, 10 Meetings contribute according to the formula, 9 Meetings do not contribute, and

the balance contribute according to their own formula. Discussion included whether formally reported "members" who are no longer actively involved with the Meeting should be counted, and whether active attenders should perhaps be given the same value as members.

The Winter Interim Business Meeting and Mitchner Lecture will not occur on Martin Luther King Day weekend but on the following weekend (Jan 20-21) at the Orlando Meetinghouse. The Lecture, tentatively titled "Let It Burn," will be given by Ann Jerome of the Deland Worship Group, who is currently a Friend in Residence at Pendle Hill.

Yearly Meeting Sessions will be held once again at the Dayspring Retreat Center (between Sarasota & St. Petersburg) on March 27-31 (ending on Easter Sunday). The theme will be "The Friends we are becoming; embracing our longings and leadings."

The position of youth coordinator is currently vacant. We approved the search to fill the position.

Friends shared a concern that there has been neither a merit increase nor a cost-of-living increase in SEYM staff salaries in the past 3 years.

There was a brief presentation and discussion about a potential Florida Constitutional "Amendment to Limit Government Interference with Abortion," whose summary states, "No law shall prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as determined by the patient's healthcare provider."

The Ad Hoc Florida Retirement Community Committee was laid down after the committee found inadequate interest on the part of monthly Meetings. Other ideas are being explored.

Friends approved the establishment of the Quaker Call Committee, charging it with "the responsibility to develop creative ways and means to actively resist the frontal attack now being made in Florida and elsewhere upon our historic Quaker Testimonies and, more positively, to invigorate and strengthen our Monthly Meetings." Dan Vaughan, the driving force behind this, shared his thoughts about the possibility of establishing a school or schools in Florida that teach Quaker values and actively resist legislation

restricting public funded education about history, science, and gender, diversity, equity and inclusion.

Suzanne noted that she is participating in this newly-formed committee. One idea being discussed is to explore tapping into the expanded Florida school voucher system, (\$8,000 per student made available to parents who choose to not send their children to public schools). In so doing, those funds might be used by parents to support educational objectives aligned with Quaker values. There has been some early discussion between Dan and administrators he knows well at Stetson University in Deland, Florida, about the possibility of the university revisiting the notion of a lab school there. Although Stetson considered establishing a lab school in the past, it never materialized. The Florida school vouchers might provide an impetus for funding and the recent ultra conservative educational mandates of the legislature may identify the need. Suzanne reported that she is participating in this newly formed SEYM Quaker Call Committee.

The Meeting closed with silence at 12:55 pm

Do not attempt to address all these queries. They are simply intended to assist you in thinking about how spirit works through your Meeting. Of course, if there are other queries that are more meaningful to the spiritual state of your meeting, by all means add and use them.

We ask that you respond to those few queries that speak deeply or directly to you or add a query that does the same. Please send those thoughts responses before December 1 to the Clerk of Ministry and Counsel at nrmurvine@gmail.com to allow time to create the report and deliver it to the Meeting in early January.

- 1. How do we support each other as members of this beloved community?
- 2. How well do our meetings for worship with a concern for business lead to a corporate search for and revelation of God's truth?
- 3. What was our meeting's witness in the wider community in the last year?
- 4. How has our meeting for worship or other meeting activities nurtured our spiritual growth?
- 5. Has there been a deepening and strengthening of the sense of the Divine Presence in our midst during the pastyear? Do we feel a sense of our individual spirits fusing into an undivided group as we worship? Do we leave our meetings filled with a sense of love and peace and courage to meet the challenge of Spirit filled living?
- 6. Where do you find hope in the meeting and in the meeting's spiritual life?
- 7. How is God's presence being experienced in our meeting?
- 8. Are there places where the meeting isn't reaching fully for the Light?
- 9. Do you have other reflections on the current condition of the meeting—places where you see new life emerging or loss or sadness that you want to share?
- 10. How does the spirit of worship extend into our committee work and into meeting for worship with a concernfor business?
- 11. How does love manifest in our meeting, in our community, and in the world?

Report on lobbying for peace from Helen Fox, FCNL liaison:

This year FCNL is lobbying for strong investments of federal spending in three core accounts that fund peacebuilding: Atrocities Prevention, Complex Crises Fund, and Reconciliation Programs. These will come up in the fiscal year 2024 State Department and Foreign Operations Appropriations bill (H.R. 4665/ S.2438).

Atrocities Prevention is the State Department's only funding dedicated solely to the prevention of mass atrocities and genocide.

The Complex Crises Fund allows for the quick mobilization of funds during emergent crises, and seizes opportunities to consolidate peace.

Reconciliation programs facilitate interpersonal dialogues between conflicting groups to strengthen social cohesion and trust.
